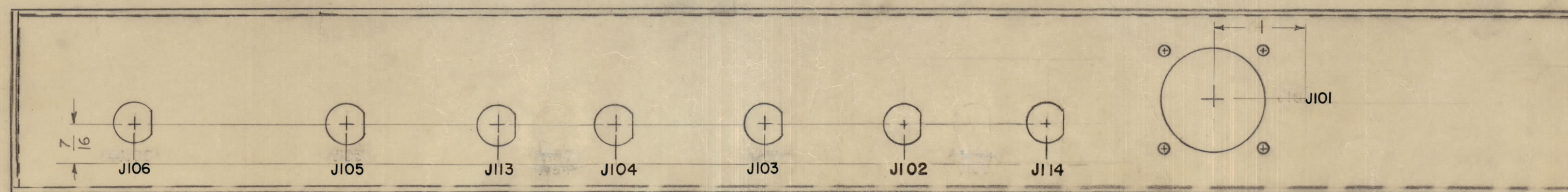
FRONT of UNIT
